Para as Bermudas não é necessária a emissão de certificados sanitários nem a *intervenção dos serviços oficiais (DSAVR/RA) na documentação sanitária exigida*.

É necessária a emissão de uma licença de importação por parte dos serviços oficiais das Bermudas, cujas condições para entrada nesse país e respetivo procedimento se encontram nas páginas seguintes.

O eventual regresso à União Europeia implica:

Aceda aos links preferencialmente através do Google Chrome

- **Identificação do animal com microchip** (efetuada em data anterior ou simultânea à vacinação contra a raiva);

- **Vacinação contra a raiva válida**, que só pode ter lugar a partir das 12 semanas de idade e:

Se tiverem **decorrido pelo menos 21 dias** desde a finalização do protocolo de vacinação requerido pelo fabricante **para a primeira vacina** (primovacinação) ou se **a revacinação** (reforço) foi **efetuada cumprindo as condições exigidas para utilização da vacina escolhida no país de origem e consequente indicação na documentação do animal**, caso contrário a vacinação a conferir ao animal deve ser considerada como uma primeira vacina;

- **A emissão de um certificado sanitário que corresponda ao modelo comunitariamente previsto, validado pela autoridade oficial competente do país de origem. Este certificado é válido por 10 dias a contar da data de emissão até à data em que é efetuado o controlo do animal no Ponto de Entrada dos Viajantes. No caso de transporte marítimo este prazo pode ser alargado considerando o tempo da viagem.**

Um passaporte emitido na UE antes da saída do animal para um país fora da UE, onde foram registadas as condições sanitárias previstas na legislação (de que são exemplo a identificação/vacinação/revacinação contra a raiva), é válido no regresso à UE em substituição do certificado sanitário, se não houver alteração dessas condições sanitárias que alterem assim a informação que consta no passaporte.

CONDITIONS OF ENTRY FOR DOGS & CATS INTO BERMUDA

All animals arriving in Bermuda must be accompanied by an Import Permit issued in advance by the Department of Environment and Natural Resources, together with an original of a health certificate issued by a licensed veterinarian of the country from which the animal is coming. The health certificate and veterinary statements must be issued within the 10 days before the animal's arrival, must be dated, must show the name, address and phone number of the veterinary facility, and must be signed by a licensed veterinarian. You must provide evidence that your animal complies with **all** import requirements before we will issue an Import Permit. You must provide true and accurate documentation of:

1. The animal has been implanted with a microchip read by a standard microchip reader, i.e. ISO, FECAVA, European/International or AVID-USA chip.
2. A veterinary health certificate issued within 10 days before your arrival in Bermuda, stating that the animal is not infected with any communicable disease and is free of external parasites. The veterinary health certificate must contain the following information:-
 - (a) Name, date of birth, breed, description and microchip identification of pet;
 - (b) Owner at present; (c) Owner in Bermuda and address
 - (d) An original handwritten ink signature or a digital signature of the examining veterinarian – See instructions on submitting your application under the PROCEDURE section.
3. A veterinary statement giving the name of the acaricidal preparation which is known to have residual activity against a variety of ticks, and **was administered or applied during the examination**. Dispensing of a product for unverified use by the client is not an acceptable option. Acceptable products are listed on a following page.

NOTE: Advantage®, Advocate®, Bio-Spot®, Capstar®, Comfortis®, Credelio for Cats®, NexGard Combo for Cats®, Revolution®, Promeris® for Cats, Provecta-II for Cats®, selamectin, Sentinel®, Vectra®, shampoos and collars are not acceptable.

4. A veterinary statement that, as best as can be ascertained by your knowledge and through questioning, the animal has not been exposed to rabies nor been present in an officially quarantined rabies area within the last 6 months.
- 5.- *Not applicable to dogs or cats arriving directly from the United Kingdom, Australia, New Zealand or Jamaica*
Rabies vaccination history, showing the two most recent rabies vaccinations, and that both rabies vaccinations were given by a licensed veterinarian, and were in accord with all of these requirements:
 - The animal received the first of the two rabies vaccinations at / after the age of three months; AND
 - The animal received the second rabies vaccination 6-12 months following the first rabies vaccination; AND
 - There was no significant lapse in vaccinations; AND
 - The most recent vaccination was given at least 30 days, and not more than 12 months prior to arrival.

****Note:** - *Not applicable to dogs or cats arriving directly from the United Kingdom, Australia, New Zealand or Jamaica*
Dogs and cats under age 10 months, and dogs and cats of any age that have received only a single rabies vaccination, do not qualify for entry into Bermuda.

Contact us for advice on the acceptance of tri-annual rabies vaccines.

Veterinarians may attest **only** to vaccinations given by him/herself, given under his/her direct supervision, and prior vaccinations that are accompanied by original certificates. Veterinarians **cannot** attest to vaccines given by non-veterinarians, including owners or breeders.

- 6.- *Not applicable to dogs or cats arriving directly from the Continental USA or Canada.*
The animal has not been kept within 30 miles of Foot and Mouth disease during the last 30 days.
7. This Department may request specific photographs and/or pedigree documentation of the animal to be imported, or the parents thereof. You need not provide this information unless specifically requested.
8. When requested by this Department, you will be required to give information regarding the purpose of the animal, and the location of facility where the animal(s) will be housed. You need not provide this information at this time.

NOTE: Official documentation must not be changed once issued, and must not contain any alteration, amendment, white-out or cross-out, such that the original content becomes unreadable.

PROCEDURE

- **Veterinary examination & health certificate**

Visit your veterinarian to obtain a microchip, health certificate and the veterinary statements within **10 days** of your arrival. If the animal is coming from the United Kingdom, visit the Local Veterinary Inspector within **5 days** of your departure for an Export Permit (EHC-2921).

- **Submission of veterinary health certificate & supporting documentation**

If the health certificate contains an electronic signature of the examining veterinarian, the veterinary documents must be forwarded from the veterinary facility directly to this office via e-mail. The veterinary documents may be submitted from the veterinary facility, the client, animal owner, importer, exporter or agent if the health certificate contains an original handwritten ink signature.

- **All documents are subject to verification of their contents.**

- **Response**

We will respond, usually within 2 business days. Please ensure that your email address or fax number is shown on the application form.

- **All documents and animal(s) to be available for Customs inspection**

A printed copy of the Import Permit and the ORIGINAL veterinary certificates MUST accompany the animal and be available for Bermuda Customs on arrival.

- **Failed Customs inspection**

Because there is no quarantine facility in Bermuda, animals of failed Customs inspections are generally handled in a manner outlined below. The final disposition of any animal is at the discretion of a Government Veterinary Officer.

Animals arriving by air: Animals failing a Customs inspection, and those not accompanied by all required documentation will be immediately deported, at the importer's expense. The importer may have to accompany the animal upon deportation, also at his/her own expense.

Animals arriving by sea: Animals failing a Customs inspection, and those not accompanied by all required documentation will not be permitted on land, but will be restricted to remain on board the vessel and the vessel will be kept at deep water anchorage under monitoring by Bermuda Customs. The vessel will not be permitted to be alongside any pier or other vessel.

When a deportation cannot occur or if the owner fails to comply with the instructions of Customs or of this Department, the animal may be seized and humanely destroyed at the owner's expense.

- Special licenses are required to breed dogs, possess more than two dogs, to sell or act as broker in sale of dogs, possess or train guard dogs.

Importation and Breeding Restrictions

Law imposes restrictions on the importation and breeding of the following breeds:

Any rare, exotic or uncommon breed may also be refused entry despite its absence from the above lists. You may contact us if you have a dog of a breed that may be perceived as dangerous.

Prohibited

- Dogs of these breeds may not be imported, bred or used for breeding.

Restricted

- Dogs of these breeds may be imported under permit once the conditions for importation and keeping have been fulfilled by the importer.
- New acquisitions of these dogs require pre-approval.
- Dogs of these breeds may be bred only following receipt of a Breeder's permit.

CONDITIONS & APPLICATION TO KEEP A RESTRICTED BREED DOG

These conditions of keeping apply to persons who:

- will be newly acquiring a dog that is listed as prohibited or restricted, regardless of the source of the animal, and regardless of whether or not you already own a dog of a prohibited or restricted breed; or
- will be keeping a dog of any breed that has proved itself to be problematic.

The Dogs Act 2008 mandates the secure housing of dogs of certain breeds. The Ministry has adopted conditions for the keeping of newly acquired dogs of these breeds and individual dogs that have become problematic. Any person wishing to keep a restricted breed dog must apply to have his/her property inspected to ensure that it meets the requirements prior to obtaining the subject dog.

Any person who has been granted approval to keep a prohibited or restricted breed dog must adhere to all of the following conditions, and any additional conditions that may be imposed on his/her specific permit. Failure to do so could result in seizure of the dogs, and you will be liable in Court for any breaches of the conditions attached to your permit and/or any breaches committed against the Dogs Act 2008.

- a). Persons are **strongly advised** to consult with the Department of Planning before erecting any kennel, fence or other barrier to ensure compliance with Planning regulations. Officers of this Department cannot approve applications based on structures constructed illegally.
- b). The premises where the animal will be kept or is being kept must have an approved escape-proof kennel, enclosure or area, of no less than 60 square feet (5.6 metres²). Every entrance or gate to such kennel, enclosure or area must be secured with a dog-proof, lockable device to prevent accidental release of the animal. The owner should take steps to prevent malicious release of the animal as well.
- c). The outdoor kennel, enclosure or area must contain provisions to protect the animal from weather elements.
- d). For animals that will be primarily kept indoors, the required enclosure/area shall be easily and immediately accessible via an exit from the primary residence.
- e). The dog may not be left unattended and tethered on the property outside of the containment area; and must be on a leash and under the direct control of an adult capable of maintaining control of the animal when not indoors and not in the approved containment area.
- f). Only under very exceptional conditions will anyone be granted permission to keep more than two dogs of prohibited/restricted breed(s).
- g). The animal must still meet all of the conditions of entry (which are applicable to all dogs) before an import permit can be issued.
- h). The dog may not participate in any breeding event for at least one year following importation.

NOTE: A person wishing to import a restricted breed dog should apply this office at least one month prior to planned importation, and have the premises ready for inspection at the time of application.

NOTE: Where this Department has a record of a person owning a prohibited or restricted dog as of April 1, 2012, that ownership will be 'grandfathered', meaning that keeper will not have to construct secure housing to continue to keep that animal, except secure keeping can be required if that dog has been problematic, or should that dog stray or cause injury in the future. These conditions will apply should the owner chose to obtain a new dog of a targeted breed.

APPLICATION TO IMPORT A RESTRICTED BREED DOG

The laws of Bermuda place restrictions on the importation and breeding of dogs. This application is for **in principle** approval to import a restricted dog which is not currently resident in Bermuda, and should be submitted to this Department one month in advance of your intended date of arrival. An Animal Warden will inspect the premises where the animal will be kept. You are strongly advised to not purchase nor otherwise acquire a restricted dog until an approval has been granted. Even if you receive in-principle approval, the animal must still meet all of the conditions of entry before an import permit can be issued. **The dog may not participate in any breeding event for at least one year following importation.**
